- 3) ensure that the time of the event to which the entry relates, I or the driver or rider I have entered shall be in possession of a CERTIFICATE OF MEDICAL FITNESS made within the proceeding 12 months;
- 4) confirm to the best of my knowledge or belief that I or the driver(s) or rider I have entered possess (es) the standard of competence necessary for an Event of the type to which the entry relates and the machine(s) entered is (are) suitable and road worthy for the event having regard to the course and to the speeds which will be reached;
- 5) communicate to the GMR&SC, the Race Secretary or Clerk of the Course any change in the status which qualified me to participate in any event for which I was granted permission to participate in;

Further, I understand and fully agree that:

- 6) my participation in all games, trials and Competitions organized or permitted by the club, its officers, servants and agents, is done at my own risk and that I absolve them from and against all actions, suits, causes of actions and suits, fines, losses, damages and expenses of every description whatsoever which the club may be put to or sustain in consequences of or arising from my participation in any games, trials and competitions organized and permitted and/or carried on by the club;
- 7) the GMR&SC or the Clerk of the Course may at any time withdraw or alter any such permission granted to me without giving any reason;
- 8) I will be responsible for the conduct of my team members and/or invitees and/or crew;
- 9) I may be subjected to disciplinary action taken by or on behalf of the GMR&SC as regards my conduct or that of my team members, invitees or crew;
- 10) the GMR&SC or its officers or officials shall in no way be held liable for any expense or liability incurred by me whatsoever should such permission to participate as a competitor or official be at any time declined or withdrawn and I hereby absolve and discharge GMR&SC, its officials and/or officers of any such liability;
